Brian J. Humphrey assumed command as Director, Field Operations (DFO), San Francisco on July 15, 2012. As DFO, Brian leads a team of more than 1,600 law enforcement and support staff with responsibility for all CBP enforcement, passenger operations, agriculture operations, and trade operations in the San Francisco and Portland Field Offices. Brian is a career member of the Senior Executive Service (SES) with 32 years of law enforcement experience worldwide.

Prior to his current assignment in San Francisco, Brian served as Port Director, JFK International Airport; Assistant Director, Chicago Field Office; two tours at Washington, DC Headquarters; Division Chief of Operations, San Diego Sector Border Patrol; Acting Port Director, Miami International Airport; Chief Inspector of the Outbound/Anti-Terrorism Team at Los Angeles International Airport; and as an Inspector in Chicago.

Brian's background includes experience as: U.S. Coordinator and Instructor at the International Law Enforcement Academy, Budapest, Hungary; representative to the U.S. - Mexico Bilateral Chemical Control Working Group; and designation by a former Commissioner as the National Rail Coordinator. As the National Rail Coordinator, Brian developed a five-year strategy to address the threat of drug smuggling via rail conveyances. Brian's other law enforcement experience includes service as a Police Officer in Western Illinois and as a U.S. Army Military Police Squad Leader.

Brian earned a Bachelor of Arts degree from the University of Illinois Springfield where he served as the elected Student Senate President. He is a U.S. Army veteran with overseas service.

Brian's professional associations include Life Member, AMVETS; Life Member, University of Illinois Alumni Association; and Member, International Association of Chiefs of Police. He is also a member and past Treasurer of Lions, a service organization dedicated to assisting the sight and hearing impaired.

Brian earned the Commissioner's Humanitarian Award for leading CBPs response to the Asiana 214 aircraft crash at San Francisco International Airport on July 6, 2013. He earned the Marksman Citation for achieving at least three consecutive perfect qualification scores.
